There are currently 35 letters of comment in the record. If you withdraw, we could transfer the application fees a second time (PLLD20210908 was applied for, withdrawn to take advantage of Nov 5, 2022 BDC changes, fees were transferred over to current PLLD20211031). However, because this will trigger yet another round of new Completeness Check, we will charge a new Completeness Check fee for Planning (\$523 + 4%) and Engineering (\$153 + 4%).

You will need to contact Engineering to see if you will need to submit for new TAM and Utility Availability Memos (typically these memos are only valid for 6 months) or if Engineering can issue some type of extension or addendum.

If you do not withdraw and resubmit, and instead submit the documents as required and described within the most recent Letter of Incomplete Application, if the application is deemed to be Complete, then you can put the application on Hold for a certain specified number of days. The total of all extensions may not exceed 245 days. If the application is determined to be Incomplete, again, then you run the risk of the application becoming Void on May 4, 2022.

Hi Beth and Colin - We have addressed the items in the Notice of Incomplete Application letter and are ready to resubmit. However, there is a tentative deal with the neighborhood steering committee as well. Our understanding was that if a deal is reached, the application doesn't need to be elevated to a Type III Hearing.

The plans and narrative have been updated to reflect the neighbors' terms, but finalizing the deal is contingent on a conversation with Colin and confirmation that a Type III Hearing will not be required. We want to resubmit and be deemed complete before the application expires, but also want to be sure that it doesn't get noticed as a Type III Application before Glenn and Colin have a chance to discuss.

Beth - The application expires on May 4th and it sounds like Colin returns to the office next Monday, May 2nd. Which of the following would you suggest:

- Resubmit all documents to City View now and hold off on mailing a Notice of Application until Colin returns and has a chance to look into the Type II vs Type III situation.
